**ORDER ADOPTING AMENDMENT TO
ST JOSEPH COUNTY VOTE CENTER PLAN**

WHEREAS, the St. Joseph County Vote Center Plan ("Vote Center Plan") was duly adopted by the St. Joseph County Election Board, pursuant to IC 3-11-18.1-3, with an initial effective date of January 24, 2020;

WHEREAS, IC 3-11-18.1-15 authorizes St. Joseph County to amend its Vote Center Plan, previously adopted under IC 3-11-18.1-3, by the unanimous vote of the entire membership of the board approving the plan amendment;

WHEREAS, the Indiana Election Commission pursuant to Order 2020-40 ("IEC Order"), in response to COVID-19, a world health pandemic, allows the St. Joseph County Election Board to limit the number of vote center to at least one (1) voter center for each twenty-five thousand (25,000) active voters and at least one (1) vote center for any fraction of twenty-five thousand (25,000);

WHEREAS, in accordance with the IEC Order, there are no more than 190,000 active voters on this date;

WHEREAS, the St Joseph County Election Board has determined that it is in the best interests of the community to provide a limited number of vote centers in the 2020 Primary to protect the health and safety of voters and workers due to COVID-19, and in doing so has attempted to provide a variety of geographically dispersed vote center locations to replace all of the vote center locations previously adopted;

WHEREAS, the St. Joseph County Election Board has identified twelve (12) vote centers for the 2020 Primary Election, which exceeds the minimum required by the IEC Order ("2020 Primary Vote Centers"); and

WHEREAS, the St. Joseph County Election Board desires to approve this amendment ("Amendment") to the Voter Center Plan, as set forth herein.

**BE IT, THEREFORE, ORDERED BY THE ST. JOSEPH COUNTY ELECTION BOARD
THAT:**

The 2020 Primary Vote Centers identified in Exhibit "A" attached hereto and made a part hereof by this reference are to be open on Election Day, from 6:00 AM to 6:00 PM, in St. Joseph County, Indiana.

The St. Joseph County Election Board hereby adopts this Order approving the Amendment to the St. Joseph County Vote Center Plan.

This Order shall take effect immediately and may only be rescinded by the unanimous vote of the entire membership of the St. Joseph County Election Board.

CERTIFICATION OF ACCESSIBILITY



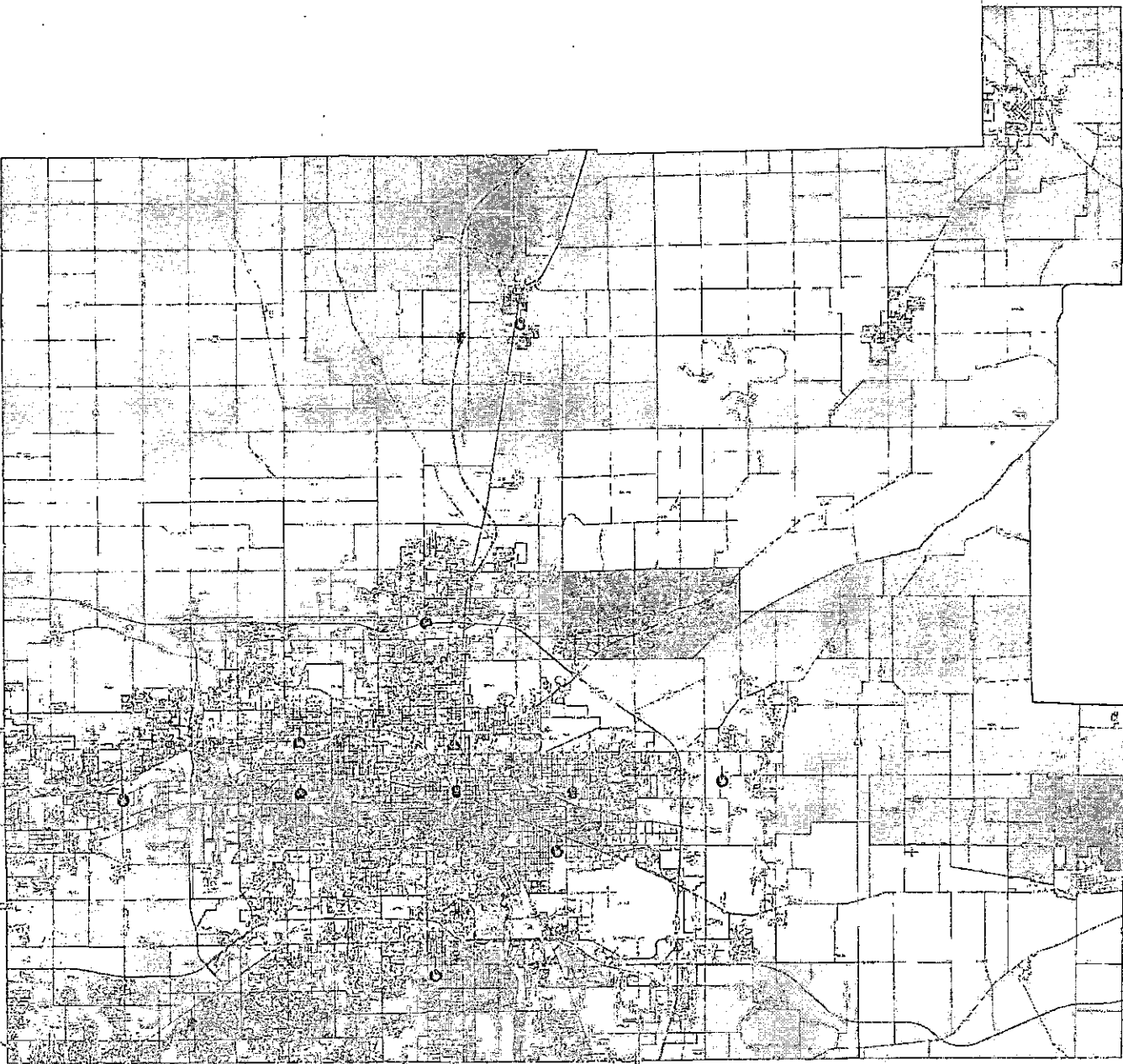
